9. Staff Reports:

Lynn Schmitt-McQuitty, Youth Development advisor, Tri County – Lorins old position as Military Liaison will be available soon. 8 hrs a week, \$15 an hour. Science Mentoring program at Alisal starting Feb 1. San Benito Office is moving. Lynn will have new phone #, and will have it by the end of Feb.

- 1. Lorin Lurz, 4-H County Program Rep- LCORT update 27 members are signed up to go, 5 chaperons and the event has spent 4,950 of the \$5,000 council budget. Members have received their orientation and I'm looking forward to the stories when they get back!
- 2. Club Bylaws and Club rules. To date I have had 1 training session with 3 clubs and another one planned for Greenfield. In each CCL packet is a copy of the "dream bylaws" that I worked on over the quiet days of the holiday. These are examples of bylaws that are in line with the 4-H program. Some came from clubs, some were improved upon from clubs and some items were from concerns that have been shared.

It is recommended for all matters that do NOT go under bylaws governance, that your club considers "Club Rules". These are matters that are specific to your club. Possibly even things that have "always bee". It needs to be in writing so that members and parents can be notified of these matters.

Again, I've heard from a number of clubs who have reworded their problem areas and have presented once before the membership and plan to vote in by their February meeting. Thank you. Reminder – all bylaws changes need a 2/3 vote. If your club has been notified by me that there were areas that needed to be modified and you have not, your club has not had its bylaws signed by the county director and therefore your club is not in good standing. That is a step you will want to take as fair season is coming up.

If you are a CCL or officer advisor that has presented these ideas before the club and you have received blank stares or phone calls telling you are wrong – please consider the training I offered. I have had one training and review session with spring, BV and Greenfield and I am offering another on February 3rd in Greenfield.

- 3. **Financial policy training** to prepare for club budget planning in March As I move ahead to begin to help clubs review club budget's for next year, Plan on training around March, I will host a Financial policy review. It will be a "fireside chat" I will meet with adult volunteers, parents and members to review financial policy of the 4-H program. This is not treasury, not bookkeeping, not the nuts and bolts of club money. That date and location will be sent out soon to CCLs.
- 4. **New Outreach flyer for club use** There is the final version of the new generic 4-H flyer that will be used for all outreach. Have a look. It is currently being translated into Spanish. You can write comments on this form tonight. This will post on the website so you can download and use at anytime.
- 5. Club scholarships review update- thank you to the clubs that have turned in their scholarships. I am reviewing them and researching the guidelines that clubs should consider when awarding money to youth members. You can plan on there will need to be written criteria, a committee to review and dates for submission. Clubs cannot just give more than \$25 as a gift. Any questions?
- 6. **Ideas for adult/parent** volunteers for clubs during this club bylaw review, many CCL asked "what can I make my parents do?" Let's move away from making members and parent volunteers do things and look at ways to ask for help for the sake of the club. Last month, some clubs shared their ways of encouraging adult and parent volunteers. I will email this list to CCLs

- 7. **Community Leaders**. Upcoming sharing date in April. I'm still planning on offering a Community leader Boot Camp for incoming, newer or even long time Community Leaders. I'm looking for a date and a location such as a barn. I'll be in touch through email
- 8. Tobacco use policy modification
- 9. **Midyear review and Club Survey**. If you are interested, this would be a good time for your club officers to consider a MID YEAR review. This is a process in which you go back to the Club program planning guide and look at what you have completed so far. This can be done at and officers meeting, and executive board meeting or a club meeting (if you have the time) This avoids things being last minute as the program year comes to a close when school is getting out, members are graduating or going on vacation and the secretary's books still needs to get done. Club surveys I'd like to propose a club challenge in your packet is a meeting survey form the 2013 officer's manual. Try using this at your next meeting. It can be a useful tool to know how much your members know about the club meetings. It can help your officers to plan productive meetings. After reviewing it, your officers may make some changes. I would love to hear about your results in using this and ask that you share at the next meeting.
- 10.**Training** I went to a 2 day new employee conference at UC Davis.
