Madison Owens from KCBR talked about her club's project to restore the American flags at Del Rey school. Julaine Mullaney from Aromas talked about their ongoing trash bag challenge to help clean up their community.

The president asked clubs to share what officers positions they have outside of the 4-H officers manual. Buena Vista and Lockwood have activity officers that oversees the recreation at club meetings, Aromas and others have healthy living officers that give away healthy living tips every month, and other clubs talked about the roles of hosts/hostesses at meetings.

After these youth reports, door prizes were given away to the youth members in honor of St. Patrick's Day.

# County Presentation Night:

Gonzales (overall, entertainment, refreshments): A thank you was given to the All Stars for entertaining the kids during tabulations. It was suggested that Refreshments would be a separate committee and that the tabulations committee can pick up a little more work next year. It was decided that a list would be constructed showing the various committees clubs are in charge of and rank them in terms of man hours needed to complete. Clubs will then pick or be assigned to the committees based on man hours and club size.

Lockwood (tabulations, judges trainings): Reported that judging went smoothly this year with great participation from room runners.

Fashion Review: Buena Vista

County wide Fashion Review will be held on April 25<sup>th</sup>. The theme is "Through the Looking Glass" with emphasis on fashion trends of the past and will have five categories. Council Food Booth:

Royal Oaks requested two checks for \$100 each in order to make reservations for the food booth and Dippin Dots booth. Request was approved.

Guest Speaker: Monterey County Fair Representative Kelly Violini.

Kelly suggested that 4-H kids no longer be required to host the 4-H building and suggested an informational booth staffed by MCF volunteers or 4-H volunteers instead, if interested. This suggested is open to discussion and will be revisited.

# **Staff Reports:** Lorin Lurz.

California Focus: Five day event in Sacramento for youth ages 14-19 and is similar to Washington Focus. Deadline to apply is the end of the month.

Bio Security Program: Live stock leaders need to sign up and attend informational meetings on how to lead the research for the nine-county wide bio security program led by UC Davis. Session will be held on April 25<sup>th</sup> in Watsonville

SLC will be held at UC Irvine. Registration will end April 30<sup>th</sup>, if every youth who signs up puts that a bus desired then it may be \$50 per person for transportation. Clubs are reminded to put scholarship monies aside to help their members attend.

Presentation Review: California presentation manual is being updated at state. If you would like to make recommendations to the manual it is open for suggestions in April and May. Updated guidelines go into effect in July.

Outreach ideas: Reminder to clubs to make outreach efforts to not only get new members, but new adult volunteers and information to the general public.

Officers: Clubs are allowed to add new officers and have positions filled by multiple people as long as specific guidelines are written about their duties, voted in, and included in club's bylaws.

Updates and new policies are coming forward from the Statewide Policy Review committee regarding what it means to be a member in good standing.

This excludes junior (11<sup>th</sup> grade) or senior (12<sup>th</sup> grade) for the 2014/2015 4-H year. And seniors (12<sup>th</sup> grade) for 2015-2016.

- 5. This county will adopt the criteria for a contest and the verification book developed by and recommend by the committee efforts. Due to confusion over this matter, the president did not present for a vote.
