Barbara Allen-Diaz, UC Vice President, Dir. AES & CE Bill Frost, UC Assoc. Vice President, Assoc. Dir. AES & CE

Barbara Allen-Diaz and Bill Frost updated us on UC President Napolitano's new initiatives, a push for full equivalency of Specialists and Advisors with Senate Faculty, the ANR Competitive Grants program, the issues around UC ANR branding, new Vice Provost position, Orientation & Mentoring, and Cooperative Extension Centennial Celebration.

Kim Rodrigues updated us on administrative matters. ANR will be hiring a ombudsperson soon ("one stop shop for complaints"). Orientation & mentoring – two orientations held in past year one is spring and fall. These covered both administrative and programmatic overview. Allen-Diaz and Frost are interested in an orientation that would be for Specialists too; covering needs assessment, engaging stakeholders, developing program, measuring impacts. Providing all new ANR academics with programmatic tools.

Challenge: expectations and M&P processes are different on each campus, each campus or department has different values. Currently, blogs and such outreach tools are not given credit in promotional packages. A Specialist at UCB has taken this on to look at this. So mentoring should include department chairs so that they know what Specialists are supposed to be doing. Mentoring is now highlighted in Advisors Merit and Promotion Guidelines ("eBook").

New position of Vice-Provost is in recruitment – they will work closely with CDs and county offices; CDs will report directly to them. They will also be AAC's liason to Allen-Diaz and Frost. Recruitment closes March 31st

Kim updated us on other current ANR academic recruitments that are underway.

There was discussion about IPM advisor positions – advisor vs. specialist positions for new IPM positions. A suggestion was made that Specialists might be the better route for future hires?

IPM Review recently finished – "Tim Payne report"

ANR APU has a career equity review process, but it is not in the handbook (yet). Kim will be working with a subset of Personnel Committee on update of academic handbook section on merits and promotions.
