On April 17th, each club was able to choose their 2018-2019 council committee during the council meeting.

Your club will be responsible for:

CLUB 3 FFD DESSERT CONTEST COMMITTEE

Work in coordination with FFD Host committee. Create a well planned dessert contest for event attendees to participate in – plan baked good categories, create flyer inviting members to enter baked goods, provide adult judges for entries, prep and serve entries for Members' Choice award. Additional educational activities may include a foods and nutrition judging contest. If a foods and nutrition judging contest is included, committee is responsible for creating "approved" and scoring participant judging sheets; tabulated results shall be provided to Final tabulations Contest Committee. Must provide a flyer with information by November council meeting. Committee representative must attend planning meetings called by Host club. May request funds from overall event budget.

Committee work is defined in conjunction with the 4-H Council and 4-H staff. Committees are expected to develop annual plans of work which include:

- Time lines of needed volunteer work
- Dates of events/functions
- Development and review of expected definitions. This may also include applications, promotional and outreach materials
- Working within a Budgets
- Giving reports at Council meetings

Committees draft their annual plans of work and present them to the 4-H Council for input and approval <u>BEFORE</u> taking action or implementing the plan of work. Committees gather input for their plans of work from meeting minutes and suggestions of the 4-H community, Council and/or 4-H staff. Committees should coordinate all activities through the 4-H Council and the 4-H staff. County 4-H YDP staff and the County Director have final authority for the administration and operation of the county 4-H program.

The role of the Monterey County 4-H Council committees is to provide leadership by developing and implementing meaningful work for the youth. While committees work in partnership with the 4-H Council and 4-H Youth Development staff, the bulk of the decision making, planning and implementation lies in the hands of the committee. This structure allows for adult and member involvement in crafting the programs and management strategies to best serve the needs of the 4-H community. All committees must adhere to the mission, core values and policies of the

University of California 4-H YDP. When possible, senior youth members should be appointed committee chairs.

Your club received a white binder with information to help get your club started. It will also be a place to keep and save information for the future of this committee. We appreciate your continued support of the local work 4-H work.



4-H Competition Philosophy

4-H programming with youth is guided by an experiential learning process that includes goal setting, cognition, practice and performance. A 4-H contest is when members demonstrate what they have learned through 4-H project work, team events, activities and outside of 4-H events. Competition can be:

- an individual event against a standard (Danish System)
- an individual event against peers (Standard System)
- team vs. team competitions (Vegetable Judging, Livestock Judging, Avian Bowl, etc.)

For competitive contests in which there is a "prize" or award, a scoring system (or rubric) must be used in the 4-H contest. A committee of adults and youth must be formed to administer the contest that is fair and equitable to all.

All criteria must be listed in written form prior to the event. Age categories should be considered when appropriate. All study materials must be widely publicized. The scorecard and the scoring must be kept at the level as it was set (cannot lower the score). Prizes or awards would be reasonable to the effort such as plaques, trophies, buckles and, or ribbons (no cash).

The same is used for Team competitions. These events provide opportunities for youth to develop the interpersonal, leadership and cooperative skills necessary to be successful in the interdependent, global society of the 21st century.

Youth must be developmentally ready to handle competitions. Being recognized for performance in comparison to others can be a strong motivator for many older youth, but a deterrent to younger youth.

When planned and conducted appropriately, 4-H competition experiences enhance positive youth development and prepare youth with positive competitive knowledge, skills, attitudes, and aspirations that can lead to success through life.

Adults should be aware of when and where a contest is appropriate during a 4-H event. If a club event or activity doesn't have the resources or time to conduct a fair and equitable contest using the process listed above, then a solution would be a "**People's Choice**" or a ballot process.

These types of contests don't require a set criteria or rubric. An example would be a dessert contest in which youth would have a broad criteria with some guidelines. Members would vote for their favorite based upon their likes or preferences. Adults would be responsible for gathering the ballots or counting the votes. Prizes or awards would be smaller or have less monetary value than those associated with the competition process.

This method could also be used in costume contests, decorating contests and food contests in which there are all ages levels and the rubric would be too vague.

Relevant to the judging of contests: 4-H members are more important than 4-H contests • Learning how to do a project is more important than the contest itself. • There is more than one good way to do most things. • Every 4-Hyouth needs to be noticed, to feel important, to experience success and to be praised.
