### **County Book Judging Final Report 2018**

Spring 4-H County Commitment
Judging Dates July 23rd - Salinas and July 24th - King City

The Monterey County 4-H Club Book Judging was held on July 23 and 24, 2018. Spring 4-H was the club in charge of the event. The Club Committee began planning the week of May 14th with emails to Lorin as we had not had any information from her sent to us. Upon information being provided that Club books were due on the 17th of July we set the judging dates for the 23rd and 24th of July.

Our first order of business was to draft a flyer and send to the County Office for approval. The Spring Committee also utilized SignupGenius to make it easy for people from all clubs to sign-up and learn and grow through this event. The county Office also continued to blast emails to club leaders to make sure each club was represented on one of the two judging nights.

Our turnout in Salinas on July 23rd was over 30 people. We began the event promptly at 6 pm with a light meal and refreshments. Then Kelly Violini went through and explained the judging sheet, the binders, the reason to have these documents etc. Lorin Lurz then spoke on behalf of the County office. We began the judging process about 6:20 (please see the picture section for room set-up, etc). With this great turnout we judged all but 4 books(Spring and Buena Vista) that were held back to be judged in King City the following evening.

The King City event had a very poor turn out. There was 3 adult advisors and 2 youth members there to judge. We also provided a light super and refreshments for them and brief training as they all had previously judged or had prepared books.

As an overall event our committee feels it was successful. We do have changes that we would like to make and those suggestions and comments will be sent via letter to the Council under separate cover.


