INDEMNITY AGREEMENT FOR USE OF BASIC MEMBER DISTRICTS' FACILITIES, GROUNDS OR EQUIPMENT

The Bay Area Insurance Cooperative (BASIC), through and by its member districts, hereby enters into this agreement with the Regents of the University of California (University) on behalf of the University's Cooperative Extension programs as follows:

- 1. This agreement shall be in effect for a period of five (5) years beginning July 1, 2020 ending June 30, 2025.
- 2. This agreement shall apply to all Cooperative Extension Program Activities.
- 3. While University is using BASIC member districts' facilities, grounds, and equipment:
 - 1. University shall defend, indemnify, and hold harmless BASIC, its respective member school districts, officers, employees, and agents from and against any and all liability, loss, expense, including reasonable attorney fees, involving claims for injuries, damages or death caused by or resulting from negligent or intentional acts, including but not limited to negligent supervision by University, its officers, employees, agents or volunteers during the use of the school facilities, grounds, or equipment. To the extent of these indemnifiable liabilities, the University shall name BASIC, the member district, its directors, officers, employees, agents and volunteers, as additional insureds under its liability insurance coverage agreements, self-insurance agreements, or joint powers authority agreements, subject to a minimum limit of liability of \$1,000,000/claim and further, subject to a 30 day notice before such insurance or coverage is cancelled or terminated.
 - 2. BASIC's member districts shall defend, indemnify, and hold harmless University, its officers, employees, agents and volunteers from and against any and all liability, loss, expense, including reasonable attorney fees or claims for injuries, damages or death caused by or resulting from negligent or intentional acts of its officers, employees, agents and volunteers, and, including but not limited to, negligent ownership and maintenance of school facilities, grounds and equipment of the member district. To the extent of these indemnifiable liabilities, the member district shall name the University, its directors, officers, employees, agents, and volunteers, as additional insureds under its liability memorandum of coverage, subject to a minimum limit of liability of \$1,000,000/claim and further subject to a 30-day notice before such insurance or coverage is cancelled or terminated.

- 4. BASIC's member districts reserve the right to deny the use of district facilities or equipment to University or to not accept the terms of this agreement, at the district's sole discretion.
- 5. BASIC agrees that the terms of the hold harmless and indemnification agreement in paragraph 3 above shall supersede the hold harmless and indemnification agreement which may be contained in a district member's "USE OF FACILITIES" form unless the language in paragraph 3 of this agreement is specifically rejected by BASIC member district.
