## Staff Report- Lorin Hofmann-Lurz

Club End of year documents are due today. She will begin the audit process for all 28 clubs. If for some reason your officers had difficulty in finding a form, or completing a form, please tell let her know now. Missing forms puts the reporting behind schedule.

The committee that normally puts on the training and judging event was removed from the list of committees. Help is needed from any club. The judging portion comes with 2 perpetual trophies. One for Secretary's book and one for Treasurer's book.

Portal club financials should be done using the 8.4 form. Every club has received their memo and password to log in.

If your club leader or, treasury parent is moving on, your club would be to vote in the new signers. Update this information at the bank until it is done – do not assume it is complete. A number of banks have eliminated giving social security number on the form and now its just a signature. If your club is missing a form, missing a signature, or, is incorrect, she will send one courtesy notice. Possibly with questions or a new deadline. If it is still not resolved she move towards the 4-H state office required protocol. That is a letter from the county director directly requesting the required document to be turned in. it is the discretion of the county director on how and what happens at that point.

Attendance has been low on summer trainings. The office will try Doodle Poll to find good dates.

Over the summer, your incoming officers should have time to be trained in their role. This is required and almost every club will be done before the first club meeting of the year. Its in the Program Guide as one of your goals. If your club needs ideas, just ask.

Officers need time to review club bylaws and club rules, project polices, animal contracts. Those documents are to be voted in by the time the Beginning of the year reports are due. If you need more resources on what is appropriate to spend club money, please contact her.

Record Books- thank everyone for keeping the record book alive! Star ranks will be compiled and confirmed before Achievement event. Remember, the club committee working on this. is Carmel valley and this is their first year. Please be patient and respond quickly if you are asked a question regarding a record book from your club.

Awards forms are due tonight but tomorrow is fine. We need time for pins and awards to be gathered. Also could use help to assemble these from volunteers who enjoy organizing.

Thank you to the clubs that have turned in their projects and their Internet to Return.

The staff will receive our first training on the new enrollment system tomorrow.

The Campus extension adult volunteer video training is open and fully functioning. Its updated and Club leaders and VECs can go in and watch their videos now.

We plan to send out numbered enrollment memos this year to keep VECs on track. Our county re-enrollment deadline is tentatively September 27<sup>th</sup>.

The survey will be used for first time volunteers only. Not everyone.

The cost of enrollment was set last month. To date, it will not be processed through the council's bank accounts and treasurer, it should be processed through an online credit card system.

If this was useful, you may want to keep some of the budget for these items. However, money raised for your 4-H club is to be used to *further the education*.

Clubs may return to food fundraisers as long as one adult has taken the Safe Serve course from the Health Dept.

All promotional items with a 4-H clover must have approval from the county offices. Even if you have printed them before. The county director is responsible for this approval to use the Clover.

If your club uses the Club Management Team method in which the volunteer workload is distributed, roles are clearly defined, an internal calendar is set, and you need a refresher, contact the office for a session.
