Official Show Rules

1. This is an ARBA-sanctioned Triple Open-Triple Youth, one-day carrying cage show. This show will be governed by the latest rules of the ARBA. Your entry indicates your acceptance of these rules. All cages must be leak-proof. Any unhealthy rabbits must be removed promptly from the showroom.
2. Showroom will open at 7:30 a.m. Judging will begin promptly at 9:00 a.m.
3. All rabbits must be permanently and legibly marked in the left ear.
4. All rabbits are entered at the owner's risk. Every precaution will be taken to safeguard and minimize hazards, losses, and mistakes, but show personnel, judges, and the San Benito County Fairgrounds are not responsible for injury or death to any animal.
5. Exhibitors are responsible for getting their rabbits to and from the judging tables. There will be no recall of classes for missed rabbits. Judging for Shows A, B and C may run concurrently and may not necessarily follow each other.
6. **All entry fees, including email fees, must be paid in full before judging starts.** There will be no refunds of exhibitor fees.
Should you enter and not attend, you will be billed for your entry fees.
7. For booth space, contact Chris Zemny rabjudge@sbcglobal.net Card table sales \$20 per table. Commercial booth fee \$75.
8. Please be considerate when setting up your space so we have room for all the rabbits and exhibitors.
9. All show reports and ARBA legs will be emailed. All awards must be picked up the day of the show at the awards table.
10. Any issue arising that cannot be resolved by reference to the above rules shall be decided by the official show committee whose decision will be final.
11. No rabbits under eight weeks of age will be allowed in the showroom. Rabbits & Cavies are the ONLY animals allowed on the showroom. NO OTHER ANIMALS or PETS WILL BE ALLOWED IN THE SHOWROOM per San Benito Co. Fairgrounds. Legally authorized service animals excluded from this rule.

3. Any entry changes may be emailed to Dolores at morrisrex@yahoo.com prior to Tuesday, 11/28 at midnight.

4. Only Ear changes may be made the day of the show for no charge. The exhibitor is responsible for making sure changes ear number changes are made to judging cards and control sheets.

5. Day-of-show changes in class, sex, or variety must be made with the show secretary for an additional \$5 per rabbit fee.

6. One exhibitor per entry form, please. If you need additional forms, you may copy the entry form or use a blank sheet of paper.

Be sure your entry information is legible. Call the show secretary if you have any questions on how to list your entries.

7. Youth may enter both open and youth shows using different animals and must use separate entry forms for open and youth shows.

8. All bank-returned checks will be assessed a \$50 return check fee.

9. If you are entering via email, you must include the following information in your email: Exhibitor name, address, city, state, zip code, telephone number and email address; whether entering open or youth, and breed, variety, sex, and class of rabbit. Please indicate if you are entering show A, B, and/or C or all three shows.

10. If you are entering on-line, you are responsible for your entry fee whether you attend the show or not.

Directions from Hwy 101 going north: Take Hwy 156 (San Juan Bautista) exit and bear right. Stay on this road past San Juan Bautista (SJB/Hollister Rd.). Turn right at the signal onto Union Rd. Continue on Union, winding around the outskirts of Hollister, to the 4-way stop at Hwy 25/Airline Hwy. Turn right and continue past Tres Pinos to Bolado Park Gate 2 - San Benito County Fairgrounds.

From Hwy 101 going south: Take Hwy 25 (Hollister/Pinnacles) exit and go back over the freeway. Continue on Hwy 25/Bloomfield Rd for 20 miles (past Tres Pinos to Bolado Park)

From Hwy 5: Take Hwy 152 West (Pacheco Pass) to Hwy 156 (after Casa de Fruta). Follow Hwy 156 to the signal at Fairview Rd. Turn left and continue to the 4-way stop; turn left on Hwy 25/Airline Hwy and continue past Tres Pinos to Bolado Park.

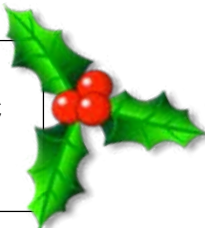
