Anything But Animals (ABA) Judging 101 Manual

Judging is a process to help 4-H members grow in the abilities to think, reason, and make logical and scientific judgments.

There are four steps in the judging process:

- Observe
- 2. Examine and Compare
- 3. Decide
- 4. Give Reasons (Tell why)


We all make decisions all the time. Judging days are when our skills to make the best decision possible are put to the test. It helps us figure out why we make decisions and the rationale behind them. Similar to Livestock Judging, the judging of classes in ABA is using your knowledge and experience.

Individual Judging

Use what you know to compare with the rest. There should be quality differences in each item; no matter what it is you are comparing. There should be one that stands out as great and one opposite. The hard ones can be the two in between. Just take a moment to always compare your items against your best (put this item number first) and your worst (put this item number last).

- 1. Read through the description and study the objects.
- 2. Use the steps above to decide on how to rank the objects on comparison in the class.
- 3. Log your findings on your scorecard.

Example Question: Look at these four drawn circles. We have been looking at circles throughout life so far. Use that knowledge to rank the following from best to worst:



After using the process, you should conclude the following ranking:2-3-1-4.

Circle 2 is perfectly round and is perfectly drawn, uniform in shape. Circle 3 has a little 'wobble' drawn into the line, which is less uniform. Circle 1 is a more inconsistent in shape than Circle 3. Circle 4 has hardly any circle shape to it; not uniform at all.

Giving Reasons

The oral presentation of giving reasons is more important than the ranking itself. More is learned by the process of producing reasons:

- 1. Organize Thoughts
- 2. Expression through logic in a convincing presentation.
- 3. Speaking Effectively
- 4. Analyzation
- 5. Fast Thinking
- 6. Testing Memory

After judging all the classes for your age division, choose a class for giving reasons. Go back to your notes and fill out your card with your notes and observations.
